



# Vintage Machinery 2026

## Exhibitor Terms and Conditions

All exhibitors are required to abide to the below:

### Exhibit criteria

1. All exhibitors and exhibits must be registered with the show office. Only registered entries will be allowed into the Vintage Machinery section.
2. All exhibits must pay **£5 Administration Fee when booking. Late entries will be considered and incur an extra £5 fee.**
3. All exhibitors must comply with the safety code in operation for the show.
4. All entries MUST be covered with public liability insurance of at least £4,000,000.
5. All exhibitors must comply with any direction given by both the Stewards and the safety officer.
6. Exhibitors must remain close to their exhibit when exhibit is in operation.
7. Vehicle movements are strictly prohibited during show times except for movement to and from the main ring.
8. All exhibitors to display for the full 2 days of the Show. Including entering the Main Ring.
9. Exhibits must be in place by 8:30 on day 1. Exhibits not in place by then will be refused entry. If an exhibitor is leaving the site and returning for the 2<sup>nd</sup> day of the show they must be in place by 8:30 **THERE IS NO VEHICLE MOVEMENT AFTER 8AM AND BEFORE 5PM ON DAY 1 AND 4:30 ON DAY 2, EACH OF THE SHOW DAYS**
10. No Military vehicles or vehicles in Military colours will be accepted, and the decision of the society is final.
11. **Current insurance details must be included on the Application Form, and also brought to the show for all exhibits. Failure to do so may result in the society refusing entry into the Vintage Machinery section.**
12. **Motor Car and Tractor** exhibits must be 40 years and Older and cannot be replaced or exchanged without permission.
13. Stationary Engines must be above 1<sup>1/2</sup> BHP.
14. **All Stationary Engines** must be displayed running during the show.

15. Right of refusal or removal: The Society, through their Show Directors shall have full and free right to refuse to accept any exhibit to cancel any exhibit after registration being made and accepted, to refuse admission to the Showground of any proposed exhibit and/or to remove, or order to be removed, at the risk and expense of the owner thereof any exhibit which has been admitted to the Showground. There shall be no obligation upon the Society or Vintage Machinery Committee to make or offer any explanation or reason for any such action and the Society or Vintage Machinery Committee shall not incur any liability or responsibility in this matter.
16. In the event of any dispute, the stewards and safety officers' decision is absolute and final.

### **Exhibitor Terms and Conditions**

#### **Special Note:**

Due to showground security measures, exhibitors not displaying or having the appropriate vehicle passes or wristbands, will be refused entry to the showground without exception.

1. Access to the Showground, Vintage Machinery Section will be available from: **10am Monday, 15<sup>th</sup> June 2026**. All exhibitors must depart from the Show ground before **12.00 noon, Thursday 18th June 2026**.
2. **Early arrivals** are strictly by prior arrangement with the show office.
3. Exhibitor event units (car, caravan, trailer, camper, arctic trailers etc) must not exceed 6.5 metres in length and 2.5 metres in width. Vintage exhibitor camping (including arctic trailers) will be located in a designated area and not where exhibits are displayed.
4. Awnings and Gazebo's are **strictly prohibited** on the showground.
5. **No Parking** unless under the supervision of a Vintage Machinery Steward
6. Exhibitors will be issued with Two complimentary 2day Wristband per exhibit. Additional tickets can be purchased through our website. [www.royalcheshireshow.org](http://www.royalcheshireshow.org)
7. One complimentary vehicle pass, and one complimentary caravan pass will be issued per exhibit. Passes must be always displayed. (*Caravan Pass only issued if required*)
8. **Caravan parking is limited** within the Vintage Machinery section and in the interest of Health and Safety, is strictly operated to The Caravan Club criteria. Allocation of Vintage Machinery section caravan parking will be allocated at the discretion of the Vintage Committee.
9. Cheshire Agricultural Society CIO accepts no responsibility for the loss of any complimentary tickets or vehicle passes under any circumstances. Re-issue of tickets or vehicle passes will incur the usual entry fee.

**10.** Any exhibitor found and proven to be, or having damaged Showground property, will be removed from the showground and be open to prosecution as appropriate.
